APIARIES (AMENDMENT) BILL:—

Clause 1, having been dealt with,—

Clause 2. The Apiaries Act, 1916, as amended by subsequent Acts is amended—

(h) by omitting section twelve and by inserting in lieu thereof the following sections:—

* * * * *

12B. (1) If, upon the prescribed application being made to the Minister, a beekeeper satisfies the Minister—

Protected
apiaries.

(a) that he is carrying on the business of a bee farmer; and

(b) that he keeps on any apiary registered by him under section twelve of this Act at least fifty hives of bees; and

(c) that he has carried out work on such apiary or on land in the vicinity for the purpose of improving the apiary as a site for bee-farming,

the Minister may direct that such apiary shall be registered as a protected apiary and that a certificate of registration thereof as a protected apiary shall be issued to him.

(2) No person shall, without the consent in writing of the Minister, move bees or cause or permit bees to be moved into or upon any land which is situated within the prescribed distance from any external boundary of the site of an apiary in respect of which a certificate of registration as a protected apiary has been issued under this section.

The prescribed distance for the purposes of this subsection shall not in any case exceed two miles.

LOCAL GOVERNMENT (ELECTIONS) BILL:—

Clauses 1 and 2 having been dealt with,—

Clause 3. (1) Notwithstanding anything contained in the Principal Act the ordinary election of aldermen and councillors of all areas wholly within the County of Cumberland directed by section thirty-eight and paragraph (b) of section thirty-nine of that Act to be held on the first Saturday in December, one thousand nine hundred and forty-four, is hereby postponed until the first Saturday in December, one thousand nine hundred and forty-five, or such earlier date (being a Saturday) as may be appointed by the Governor and notified by proclamation published in the Gazette not less than three months before the date so appointed.

ACCOUNTANTS REGISTRATION BILL:—

Clauses 1, 2 and 3 having been dealt with,—

Clause 4. (1) The Board first constituted under this Act shall consist of five members of whom—

- (a) one shall be the chairman;
- (b) one shall be the Auditor-General;
- (c) one shall be the Under-Secretary, The Treasury;
- (d) two shall be practising public accountants appointed by the Governor.

(2) (a) The members referred to in paragraphs (b) and (c) of subsection one of this section are in this Act referred to as the "official members."

(b) The members referred to in paragraph (d) of subsection one of this section are in this Act referred to as the "appointed members."

(3) Subject to this Act an appointed member shall hold office until the first day of July, one thousand nine hundred and forty-five, and shall, if otherwise qualified, be eligible for election as an elected member.

- "(a) one shall be the person for the time being holding the office of Auditor-General who shall be the chairman;

- "(c) one shall be the person for the time being holding the office of Crown Solicitor;
- "(d) one shall be the person for the time being holding the office of Registrar-General;
- "(e) one shall be the person for the time being holding the office of Commissioner for Stamp Duties.

"(2) Any of the members of the Board may, if unable to attend any meeting thereof, appoint some officer of his Department to attend and act for him at such meeting, and for all purposes any such officer so appointed when so acting shall be deemed to be a member."

ACCOUNTANTS REGISTRATION BILL:—

Clause 10. (1) The chairman and other members of the Board shall be paid such remuneration (by way of fees or salary or otherwise) and such allowances as the Governor may direct.

Remuneration of members of Board, cf. Act No. 28, 1941, s. 14.

(2) The office of chairman or other member of the Board shall not for the purposes of the Constitution Act, 1902, or the Sydney Corporation Act, 1932, or any Act amending or replacing those Acts, be deemed to be an office or place of profit under the Crown.

(3) An official member of the Board shall, notwithstanding the provisions of any Act, or of any rule or regulation made under any Act, be entitled to receive remuneration and allowances under this section in addition to any remuneration to which he is otherwise entitled.

[Read.]

Question proposed,—That the clause, as read, stand part of the Bill.

Motion made (*Mr. Brain*) to leave out all the words after the word "shall" on line 12 down to and including the word "entitled" on line 22, with a view of inserting the words "not receive any remuneration for their service on the Board other than out of pocket expenses."

Question proposed,—That the words proposed to be left out stand part of the clause.

Mr. Macdonald intimated that he desired to move,—That the clause be amended by leaving out from line 13 the words "or salary or otherwise" and after the word "direct" on line 14 by inserting the following words, "but not exceeding two hundred and fifty pounds per annum for each member".

Question proposed (*to test the Committee*),—That the words "be paid such remuneration" on lines 12-13 stand part of the clause.

Mr. Lang intimated that he desired to move,—That the clause be amended by leaving out from line 13 the word "such" and by inserting in line 13 after the word "otherwise" the words "not exceeding the sum of two hundred and fifty pounds per annum in the case of the Chairman and not exceeding the sum of one hundred and fifty pounds per annum in the case of other members".

- (iii) the boundaries of the land added to or taken from the City.

(b) The boundaries set forth in the Schedule referred to in subparagraph (i) of paragraph (a) of this subsection shall be the boundaries of the City, and where reference is made to the City in the Sydney Corporation Act, 1932, as amended by subsequent Acts, or in any Act, by-law, or regulation in force at the date of such proclamation, the same shall be deemed to refer and shall apply to and have operation within the City as bounded in manner set forth in that Schedule.

(c) The boundaries set forth in the Schedule referred to in subparagraph (ii) of paragraph (a) of this subsection shall be the boundaries of the ward or wards named in that Schedule.
