Terms of Reference

1. That the Budget Estimates and related papers for the financial year 2005-2006 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.
2. That the committees consider the Budget Estimates in accordance with the allocation of portfolios to the committees.
3. For the purposes of this inquiry any member of the House may attend a meeting of a committee in relation to the Budget Estimates and question witnesses, participate in the deliberations of the committee at such meeting and make a dissenting statement relating to the Budget Estimates, but may not vote or be counted for the purpose of any quorum.
4. The committees must hear evidence on the Budget Estimates in public.
5. Not more than two committees are to hear evidence on the Budget Estimates simultaneously.
6. When a committee hears evidence on the Budget Estimates, the Chair is to call on items of expenditure in the order decided on and declare the proposed expenditure open for examination.
7. The committees may ask for explanations from Ministers in the House, or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure.
8. The report of a committee on the Budget Estimates may propose the further consideration of any items.
9. That a daily Hansard record of the hearings of a committee on the Budget Estimates be published as soon as practicable after each day's proceedings.
10. That the Leader of the Government is to provide to each Committee, by Friday 1 July 2005, a schedule outlining the attendance of relevant ministers to appear before each committee, for the committee's consideration.
11. A committee must not meet to hear evidence on any day on which the House sits except during any adjournment for meal breaks or after the adjournment of the House.
12. The committees may hold supplementary hearings as required.
13. The committees present a final report to the House by the last sitting day of the second sitting week in 2006—put and passed.

Chapter 1 Introduction

Referral of the 2005-2006 Budget Estimates

- 1.1 On 6 June 2005, the Legislative Council resolved that the Budget Estimates and related papers for the financial year 2005-2006 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees (GPSCs) for inquiry and report.²
- 1.2 Each Committee was required to examine the Budget Estimates for their relevant portfolios and report to the House by the last sitting day of the second sitting week in 2006.³

GPSC 1 Portfolio responsibilities

- 1.3 On 14 September 2005, the Legislative Council resolved that the resolution appointing five General Purpose Standing Committees be amended to reflect changes to Government Ministers' portfolio responsibilities.⁴

Chapter 2 Summary of issues

This chapter provides a summary by portfolio of the key issues raised as part of the General Purpose Standing Committee No 1 Inquiry into Budget Estimates 2005-2006. For further details see the Hansard record of the hearings, available on the Committee's web page at www.parliament.nsw.gov.au/gpsc1.

Special Minister of State, Commerce and Industrial Relations

2.1 The Committee conducted a public hearing examining the portfolios of Special Minister of State, Commerce and Industrial Relations on Thursday, 15 September 2005. The following issues were examined:

- the Government's procurement policy for open source software
- the number of displaced employees within WorkCover
- the supply of broadband internet technology to Government agencies
- management of the Government's motor vehicle fleet
- on-line business licensing in NSW
- the impact of proposed federal industrial relations changes.

Fair Trading and Western Sydney

2.2 The Committee conducted a public hearing examining the portfolios of Fair Trading and Western Sydney on Friday, 16 September 2005. The following issues were examined in relation to the Fair Trading portfolio:

- the operation of the Department of Fair Trading's call centre
- the interest rate paid to tenants who have lodged rental bonds with the Rental Bond Board
- the interest received by the Rental Bond Board on rental bond payments kept in its account
- funding for the Department of Fair Trading in the 2005-2006 Budget
- funding for a pilot advocacy service for building service consumers.

2.3 The following issues were examined in relation to the Western Sydney portfolio:

- the staffing and role of the Office of the Minister for Western Sydney
- the staging of the Western Sydney Awards gala presentation dinner and other award programs.

The Legislature

- 2.4 The Committee conducted a public hearing examining the portfolio of The Legislature on Friday, 16 September 2005. The following issues were examined:
- the decision not to establish a Library Committee and House Committee during the 53rd Parliament
 - the provision of food and beverage services to Members and staff
 - the allocation of funding to Building Services in the 2005-2006 Budget
 - water saving initiatives at Parliament House.

Premier, Treasury and Citizenship

- 2.5 The Committee conducted a public hearing examining the portfolios of Premier, Treasury and Citizenship on Tuesday, 20 September 2005. The following issues were examined:
- the projected Budget outcome for 2005-2006
 - the Government's environmental priorities
 - the increase in funding for the Department of the Premier in 2005-2006
 - the Government's preparedness for a possible terrorist attack in NSW
 - changes to the superannuation scheme for new Members of Parliament
 - the policy framework for the management of displaced employees in the New South Wales public sector
 - the operation and review of the *Freedom of Information Act 1989*.

Education and Training

- 2.6 The Committee conducted a public hearing examining the portfolios of Education and Training on Wednesday, 21 September 2005. The following issues were examined in relation to the Education portfolio:
- the increase in teacher salary costs in the 2005-2006 financial year
 - the total number of school teachers in NSW
 - the promotion of teachers based on local selection
 - textbook subsidies for non-government schools
 - the viability of small schools, notably in regional and remote parts of the State
 - funding for school maintenance in the 2005-2006 Budget and the formula used for allocating maintenance funds
 - the installation of air conditioning in NSW classrooms
 - the installation of fencing to protect NSW schools

- the adoption by all schools of mandatory guidelines on healthy eating
- changes to the education program for children with special needs.

2.7 The following issues were examined in relation to the Training portfolio:

- the 2005-2006 Budget allocation for community colleges, and the Government's commitment to adult education
- the strategies and programs of TAFE NSW to identify and meet the skills shortage in NSW
- Commonwealth Government funding for training places.

Finance, Infrastructure and the Hunter

2.8 The Committee conducted a public hearing examining the portfolios of Finance, Infrastructure and the Hunter on Wednesday, 21 September 2005. The following issues were examined:

- the operation of the new Ministry of Finance, including its funding, staffing and infrastructure
- the budgetary position of the NSW Government, including the financial impact of the abolition of the Vendor Duty on property sales, GST funding from the Commonwealth Government, other NSW Government tax revenue and spending on infrastructure in 2005-2006
- the assets, liabilities and investment strategy of NSW Treasury Corporation (T Corp)
- the detection of fraud and tax evasion by the Office of State Revenue
- the recovery of uncollected fines by the State Debt Recovery Office
- the role of the Minister for the Hunter.
